Background:

According to your application for the acceptance of Type Certificate EASA.R.006 applicable to the **“AgustaWestland S.p.A.” models AB139 and AW139 rotorcraft**, the Colombian Civil Aviation Authority (UAEAC) considering that **“AGUSTAWESTLAND S.p.A.”** has submitted the requested documents, which were evaluated under Colombian Civil Aviation Regulations (RAC) and that the Colombian Civil Aviation Authority (UAEAC), has completed the EASA Type Certificate acceptance by Homologation, this authority welcomes the AB139 and AW139 rotorcraft models to operate in Colombia; however, it is important to note that we will only accept the rotorcraft configuration, certification basis, as well as the airworthiness limitations as stated in the EASA Type Certificate and the supplied documentation.

“AgustaWestland S.p.A.” will keep updated the continued airworthiness documents required to guarantee the proper operation in accordance with the recommendations of the State of Design. Any change of the information above mentioned must be reported and documented to the Colombian Civil Aviation Authority (UAEAC).



Concerning to the Post Type Validation Procedure, the Colombian Civil Aviation Authority (UAEAC) will accept the EASA findings for all post-Type Validation changes to the Type Design (including design change approvals, Airworthiness Limitations (AWL) approvals, Service Bulletin (SB) approvals, Continuing Airworthiness). In addition EASA as State of Design, for the "AgustaWestland" AB139 / AW139 rotorcraft models, will have overall responsibilities for Continued Airworthiness.

Also, and in accordance with your request for the validation of the FAA Type Certificate No. R00002RD for the AB139 / AW139 rotorcraft models, this authority has evaluated the provided by "AgustaWestland S.p.A." documentation and accepts the mentioned FAA Type Certificate.
