According to your application for the acceptance of Type Certificate FAA No. T00008WI, applicable to the **Learjet Model 45 (Learjet 45, Learjet 40, Learjet 75 and Learjet 70) aircraft** of the company "Learjet Inc.", the Colombian Civil Aviation Authority (UAEAC) considering that "Learjet Inc" has submitted the requested documents, which were evaluated under Colombian Civil Aviation Regulations (RAC) and that the Colombian Civil Aviation Authority (UAEAC), has completed the FAA Type Certificate acceptance by Homologation, this authority welcomes Learjet Model 45 (Learjet 45, Learjet 40, Learjet 75 and Learjet 70) aircraft to operate in Colombia; however, it is important to note that we will only accept the rotorcraft configuration, certification basis, as well as the airworthiness limitations as stated in the FAA Type Certificate and the supplied documentation.

"Learjet Inc." will keep updated the continued airworthiness documents required to guarantee the proper operation in accordance with the recommendations of the State of Design. Any change of the information above mentioned must be reported and documented to the Colombian Civil Aviation Authority (UAEAC).
