According to your application for the acceptance of FAA Supplemental Type Certificate No. **SA00560CH**, related to:

Install air ambulance conversion in accordance with Spectrum Aeromed Drawing List 2003DL, dated April 2, 2008, or later FAA approved revisions.

Considering that SPECTRUM AEROMED has submitted the associated technical documentation, which was reviewed and evaluated under Colombian Civil Aviation Regulations (RAC 21, § 21.515). The Colombian Civil Aviation Authority (AEROCIVIL) accepts the foreign Supplemental Type Certificate No. **SA00560CH**, for major alteration application on Colombian registered aeronautical products, in accordance with airworthiness limitations and conditions stated in the FAA Supplemental Type Certificate. The aeronautical product must be listed in the respective STC.

- 6. 2003FMS FAA Approved Aircraft Flight Manual Supplement for Air Ambulance PIPER PA-31T, PA-31T-1, PA-31T-2, PA-31T-3, PA-31P and PA-31P-350 Rev. 1 May 17/2008 or later FAA approved revision.
- 7. A letter of authorization of use of the STC signed by the appropriate person in the STC holder organization identifying A/C tail number and S/N.

Note: Please be informed that the STC includes the following models whose TCs <u>have</u> not been validated in Colombia: PA-31T, PA-31T-1, PA-31T-3, PA-31P.
