considering that Collins Aerospace has submitted the associated technical documentation, which was reviewed and evaluated under Colombian Civil Aviation Regulations (RAC 21, § 21.515). The Colombian Civil Aviation Authority (UAEAC) accepts the foreign Supplemental Type Certificate No. SA01848WI, for major alteration application on Colombian registered aeronautical products, in accordance with airworthiness limitations and conditions stated in the FAA Supplemental Type Certificate. If at any point of time, the UAEAC finds that there is a reasonable doubt to indicate that the safety of the aeronautical product is compromised because of an unsafe condition developed in the aeronautical product, UAEAC may cancel the letter of STC Acceptance.
