"Installation of the L-3 Communications NGT 9000/9000R ADS-B system in accordance with the Master Data List, L3-76AK-MDL1, FAA-approved revision."

Considering ADS-B Technologies LLC has submitted the associated technical documentation, which was reviewed and evaluated under Colombian Civil Aviation Regulations (RAC 21, § 21.515). The Colombian Civil Aviation Authority

(UAEAC) accepts the foreign Supplemental Type Certificate No. **STC SA02444AK**, for major alteration application on Colombian registered aeronautical products, in accordance with airworthiness limitations and conditions stated in the FAA Supplemental Type Certificate.


In addition, please consider that your company is responsible to keep this STC information (The alterations' published documents) updated to guarantee safe

Any major change of the STC information must be reported and documented to the Colombian Civil Aviation Authority (AEROCIVIL).

The validity of this letter of acceptance expires when the Supplemental Type Certificate approval ceases to exist. If at any point in time, the AEROCIVIL finds that there is a reasonable doubt to indicate that the safety of the aeronautical product is compromised because of an unsafe condition developed in the altered aeronautical product, AEROCIVIL may cancel the letter of STC Acceptance.
