1. INTRODUCCIÓN

Taking into account the change in schedule for the Air Review by order of the Presidency of the Republic, led by the Colombian Air Force, on July 20, 2024, in the city of Bogotá D.C., the new scheduled hours are reported. according to the NOTAM published thus:

3. EVALUATION

3.1. ACTION PLAN

- a. Airport slot requests will not be accepted for new flights in the affected slots.
- b. The SSIM messaging corresponding to the request/assignment of airport slots will be managed, as a consequence of the reduction in capacity, for flight cancellation, change and request for new slots, in accordance with existing availability.





- c. The slot distribution in other slots, resulting from the adjustment, will be carried out in accordance with fair and transparent criteria.
- d. Cancellation and slot adjustment requests will be received from July 3, 2024, at 2000 UTC and until July 5, 2024, at 1700 UTC. These will be processed starting at 1700 UTC on the same day, July 5, 2024.
- e. The final assignment, the result of the previous process, will be given no later than July 9, 2024, at 2359 UTC.
- f. In the event that flights continue without canceling or rescheduling, the slot coordination will notify you immediately to coordinate the pertinent matter.
- g. Considering the capacity reduction, the historical right of slots canceled or adjusted as a consequence of this will not be affected. The messages corresponding to these requests must indicate in the SI field the phrase /July 20/.
- h. The FCMU COL will implement the daily GDP (ARR/DEP), with reduced capacity, considering airspace and airport restrictions.
- The Directorate of Air Navigation Operations will consider the adjustment to the operating schedule of other airports, in accordance with foreseeable needs.
- j. The Directorate of Air Navigation Operations will issue the corresponding NOTAMs related to the operational conditions planned for this event.





3.2 GDP IMPLEMENTATION

The FCMU COL will implement the daily Arrivals and Departures GDP in accordance with the restriction imposed by NOTAM C2378.

The AAR and ADR capacity for the corresponding GDPs is listed below.
